Our Privacy Policy

Marriage-Moments.com is serious about protecting your privacy. This Privacy Statement explains our views and practices concerning privacy, and how they may pertain to you as a user of our website. We use the information you provide us, to schedule events, process orders and to personalize your experience on our website. The following statement explains how we gather information and how we protect your privacy.

We reserve the right to release such information to law enforcement or other governmental officials as we, in our sole and absolute discretion, deem necessary to comply with the law.

Section 1:

Collected Information

We automatically collect and/or track the following:

1. Web page http headers (home server domain names, IP address, type of client computer, and type of Web browser).
2. Information knowingly provided by you through on-line forms, registration forms, orders, surveys, and/or other entries, such as E-mail addresses, personal, financial or demographic information.
3. Information, user specific or aggregate, on what pages our visitors access.
4. E-mail addresses of visitors that communicate with Marriage-Moments.com via E-mail.

Section 2:

How we Collect Information

1. **Ordering Online** When you order, we need to know your name, E-mail address, mailing address, credit card number and expiration date. This allows us to process and fulfill your order and to notify you of your order status. For your protection, we **DO NOT STORE CREDIT CARD INFORMATION**.
2. **Promotions, Online Surveys & Announcements** If you decide to participate in an online survey, subscribe to an E-mail list, enter a contest or use one of our other

promotional features, we may ask for your name, address, E-mail address and other pertinent information to administer the contest, tabulate survey results or add you to our subscriber list(s).

3. **Browsing** We may use "cookies" to help us process your order and to customize information that we may present to you. A cookie is a small text file that does not personally identify users, although it does identify a user's computer. Cookies do not pose a threat to your computer, and they do not contain viruses. Most Web browsers automatically accept cookies, but you can change this feature in your browser.

Section 3:

Use of Data Collected

We use your contact information to send you information and promotional material about our ministry. We may also use your personal, demographic and profile data to improve our site, for statistical analysis, for marketing and for promotional purposes. Information collected by us may be added to our databases and used for marketing, SMS text-messaging, E-mails or postal mailings regarding site updates, new products and services, upcoming events, and/or the status of orders placed online. By using this site, you agree that you may be contacted in any manner contemplated in this section even if your number is found on a do not call registry, in-house list or similar registry.

When you place an order, we use a secure server to protect your sensitive information. The secure server software encrypts all information you input before it is sent to us. Your information is used only to process and send orders, bill credit cards and to contact you when necessary.
